

US Certified Crop Adviser Exam Registration for February 2, 2007

To become certified in the Certified Crop Adviser (CCA) Program, it requires passing the International Exam and the Local Board Exam for the board in which you desire certification. In addition to passing both exams, you are also required to have your work experience and educational background reviewed by your local board before certification can be granted.

To register for the CCA exam(s), you must fully complete the enclosed US Exam Registration Form. **You will receive a confirmation letter once we register you for the CCA Exam(s). The registration form and payment must be in our office by December 15, 2006.** Registration forms received after this date, regardless of the postmark, will be returned to you. Study information called "CCA Performance Objectives" are available at no charge. To order darken the appropriate circles at the bottom of the registration form. The performance objectives can also be found online at www.certifiedcropadviser.org by clicking on Exams.

If you cancel your exam registration after the registration deadline (December 15, 2006) or are not present on exam day, the exam fees become non-refundable. You must pay a \$50.00 re-application fee regardless of the exam fees paid previously to re-register for the August 2007 or February 2008 exams. After this time, the full registration fee will be required. This also applies to retest applications.

Exam Registration Directions

1. Please follow the directions at the top of the enclosed exam registration form.
2. On the back side of this letter are the boards offering the International and local CCA exams. All exams are given on February 2, 2007. The International Exam is usually administered in the morning followed by the Local Board Exam in the afternoon. Select the location where you wish to take the exam. Please carefully select the site code and cost of the exam(s). The International Exam Fee is \$150.00. The cost of the Local Board Exams can be found on the back side of these instructions in the appropriate columns.

CALIFORNIA ONLY: If you have a PCA license select the site code that indicates PCA.

3. On the registration form:
 - a. Fill in the circle for the test(s) that you plan to take. If retesting the local board exam, be sure to use the retest circle.
 - b. Fill in the test site code representing the location at which you wish to take the exam(s).
 - c. Fill in the total cost of the exam(s). Please make sure to include fees for both exams if you are registering for both the International and Local Board Exams.
4. Payment must accompany the registration form. Please make your check payable to: ASA/CCA. If faxing, you must include credit card information as requested or the registration will be returned.
5. **The registration form and payment must be received in our office by December 15, 2006 at: CCA Exam, 677 South Segoe Road, Madison, WI 53711. **NOTE: If mailing after December 8, 2006 it is strongly suggested that you use an overnight express delivery system.**

Once you have passed both exams, we will mail you the complete CCA credential booklet. We require that you fill out the forms provided within the booklet and return them to us within 6 months of passing both exams or you will be required to retake both exams at the original cost.
